



## COOKIES CAR LOCK SYSTEMS B.V.

### 1. General

Car Lock Systems B.V. (hereafter CLS) attaches great importance to the protection of your data. In this cookie statement, we want to provide clear and transparent information about how we deal with data, obtained from cookies.

### 2. What is a cookie?

On this website, we make use of cookies. A cookie is simply a small text file that is sent with the pages of this website and that is stored on the hard disk of your computer by your browser. The information stored within it can be sent back to our servers during a subsequent visit.

### 3. Use of permanent cookies

A permanent cookie allows us to recognise you during a new visit to our website. That means that the website can be adjusted to reflect your preferences. Also, when you give permission for cookies to be placed, it means we can remember this by means of a cookie. This means you don't have to continually repeat your preferences, saving you time and allowing you to have a better experience on the website. Permanent cookies can be removed via the settings of your browser.

### 4. Use of session cookies

Session cookies allow us to see which parts of the websites you have visited on this occasion. That means we can adapt our services as much as possible to the browsing behaviour of our visitors. These cookies are automatically removed as soon as you close your browser. Non-completed online orders are automatically removed from our database within 24 hours.

### 5. Google Analytics cookies

As part of the "Analytics" service, a cookie from the American firm Google is placed through our website. It is a service we use to keep track and receive reports on how visitors use the website. Google is able to provide this information to third parties if it is legally required to do so, or in the event that third parties process this information on Google's behalf. This is outside of our control. We have not allowed Google to use the analytics obtained in this way for any other Google services.

The information collected by Google is anonymised as much as possible. Your IP address is explicitly not provided. The information is transferred by and on behalf of Google to servers in the United States. Google declares that it complies with the Privacy Shield principles and that it is a member of the Privacy Shield programme of the US Trade department. This means that there is a suitable protection environment for the processing of any personal data.

### 6. Social media cookies

The social media buttons on our website do not contain cookies. They are links to the website of the relevant platform. If you make use of these links, you will leave our website and go to (for instance) Twitter. Once there, you are subject to the privacy policy and the cookie policy of the relevant platform. We have no influence on these and cannot make any guarantees in that respect. If you want to know how they deal with cookies, you need to consult their website.

### 7. Rights in relation to your data

You have the right of access, correction or removal in relation to the personal data we hold on you. You also have the right to have the details provided to us transferred to yourself or directly to a different party if you so wish. Logically, we may ask you to provide proof of your identity before we can address any of the above-mentioned requests. When this relates to access to personal data linked to a cookie, you should send along a copy of the cookie in question. You will be able to find this in the settings of your browser.
